The Trip of a Lifetime

Eighty-three of Kentucky's best and brightest rising high school seniors descended upon the nation's capital last June, representing electric cooperatives on the annual Washington Youth Tour.

Blue Grass Energy sponsored nine delegates on the all-expenses-paid, week-long experience: Logan Bechanan, Kailey Boyles, Hannah Creech, Ty Hutchens, Whitley Lemons, Alexis Koteras, Nelson Paul, Marissa Stephens and Annah Valenta.

"I have been going to the annual meetings since I was very young, and this is an opportunity that I always hoped to receive," says Ty Hutchens. "I feel fortunate to have been selected, and the trip exceeded my imagination."

En route on two motor coaches, the journey began with visits to the homes of Thomas Jefferson and George Washington, followed by more than 40 miles of walking to monuments and museums in Washington, D.C.

"As I was surrounded by incredible people, monuments, history, politicians, and current events, Washington, D.C., captured my heart," says Annah Valenta. "This trip has helped guide my decision to pursue political journalism, a passion of mine which grew much stronger after my week in D.C. And it's all thanks to Blue Grass Energy."
