MESSAGE FROM THE PRESIDENT

It's a good deal

Typically, when you hear someone received something at “cost,” you usually think they got a good deal. As a member, you purchase energy at our cost because we are a cooperative.

That means when you signed up to receive service from us, you became not just a member, but an owner, too. Unlike for-profit businesses, our primary focus is making life better and providing a needed service; not generating a profit for shareholders.

Over time, if we take in more money than needed to pay our expenses, the margins are assigned back to our members' accounts in what is called capital credits. The margins are then used to maintain and improve our system.

Utilizing these margins allows us to control expenses and keep the rates you pay as low as possible. When financial goals are met, these margins are returned to our members.

The amount of the refund you receive is determined by the amount of electricity you purchased.

This year, we are returning \$2.2 million in capital credits for margins earned in 1988 and part of 1989. If you were a Blue Grass Energy member during those years, you are eligible for a refund and should expect to see a check in the mail in the coming months.

In the last five years, we have returned nearly \$10 million to our communities through capital credits. These refunds are just one of the many ways we are making life better, the cooperative way. However, buying power at cost is a good deal, too.

Supporting our youngest members through education is an important part of who we are. That is why we offer scholarships to graduating seniors throughout our service area.

This year, Blue Grass Energy will, again, be awarding ten \$1,500 scholarships. Scholarship winners will be chosen by a random drawing following annual meeting on June 3, 2021, and announced the following day.

Eligible applicants are graduating high school seniors with plans to attend an accredited college, university or trade school, and are living with a parent or guardian who is a Blue Grass Energy member. Members of the immediate families of employees, directors and people receiving benefits from Blue Grass Energy are ineligible to apply.

Plan for the future when planting a tree

When carefully selected and placed, trees can provide your family with many years of enjoyment. They can help cool your home and neighborhood, break cold winds to lower your heating costs and provide food for wildlife.

Properly placed trees can help control costs, improve reliability, reduce tree mortality and result in healthier forest communities.

Tall trees surrounding your home, such as maple, oak, pine and spruce, provide summer shade to lower cooling costs and keep out cold winter winds. Medium trees, 40 feet or less in mature height, might include Washington hawthorne and golden raintree, while smaller trees suitable for planting adjacent to utility lines might include redbud, dogwood and crabapple.

EKPC seeks rate adjustment

East Kentucky Power Cooperative (EKPC), which generates and transmits wholesale electricity to Blue Grass Energy, along with 15 other electric co-ops, is seeking to raise its base rates. EKPC states the increase is needed in order to maintain reliable service and the co-op’s financial strength.

If approved by the Kentucky Public Service Commission (PSC), the proposal by EKPC will raise our purchased power costs; necessitating a corresponding pass-through rate case for Blue Grass Energy. This adjustment will result in an average increase of 3.71% for our residential members; adding approximately \$4.75 per month.

EKPC will file the rate adjustment request on April 1. Blue Grass Energy has also filed an application with the PSC detailing how the adjustment would be passed through monthly bills to the membership. If approved, the increase is expected to go into effect in October; and it will mark EKPC’s first increase in base rates since 2011.
